The Tennessee Department of Tourist Development is pleased to announce that we will provide two types of scholarships for the 2025 Governor's Conference on Hospitality & Tourism hosted by Hospitality TN September 17-19, 2025 in Kingsport.

Realizing that budgets are limited, the opportunity to attend the Governor's Conference on Hospitality & Tourism provides those working in the **Tennessee tourism industry** a chance to meet annually, attend educational seminars and network with industry partners. - Scholarships are for the 2025 TN Governor's Conference on Tourism and Hospitality only
- **Please do not register for Governor's Conference prior to applying for this scholarship. TDTD will register scholarship recipients.**
- Scholarship cannot be used toward a match for any grant program

THINGS TO CONSIDER BEFORE APPLYING:

- Can you or your organization pay for the expenses that would accompany attending the Governor's Conference? (i.e. travel, meals, and/or lodging expenses, etc.)
 - If a scholarship recipient needs to cancel attendance/lodging, TDTD must be notified no later than Friday, September 12. Failure to notify TDTD by this deadline will result in the recipient's organization being responsible for any registration/lodging/cancellation fees.
- How can attending Governor's Conference improve your contribution to Tennessee tourism? How can it benefit you and/or your organization?

ABOUT THE GENERAL SCHOLARSHIP:

- Up to two scholarships will be awarded to applicants in each of the grand divisions of the state in counties that are not considered at-risk or distressed
- Scholarship award will cover **registration fees** to conference only

ABOUT THE RURAL SCHOLARSHIP:

- Up to 2 scholarships will be awarded to each county designated as distressed or at-risk per the current or previous two FYs Appalachian Regional Commission guidelines
- Scholarship award will cover **registration fees and lodging** to conference only
- **Required attendance** at the Rural Tourism pre-conference training day, **September 16, 2025** (Tentative start 9:00am ET)

WHO IS ELIGIBLE?

1. You must be employed by a tourism organization / business/ Government
Examples of tourism businesses are:
 - Convention & Visitors Bureaus, Chambers of Commerce, DMO
 - Community development related organizations
 - Attractions
 - Restaurants
 - Museums

- Lodging

2. You must be able to cover the cost of travel, meals etc. and lodging if not included in the scholarship.
3. To be eligible for the Rural Scholarship, your organization must be located in a county designated as distressed or at-risk per the current or previous two FYs Appalachian Regional Commission guidelines.

****TDTD maintains the discretionary right to create exceptions or additional eligibility regulations on a case-by-case basis.***
